HYDRANT METER RENTAL AGREEMENT

1. The City of Oviedo requires a fifteen hundred dollar (\$1,500.00) deposit. Deposits shall be paid prior to delivery of the Rental Hydrant Meter. The minimum deposit at which a contractor can rent a Hydrant Meter assembly is five hundred dollars (\$500.00) and this is for a 5/8” hydrant meter only.
2. Rate for Potable Water Usage shall be two dollars and ninety-one cents (**\$2.91**) per one-thousand gallons. Plus a monthly Hydrant Meter Rental rate of: **5/8” – Eleven** dollars and seventy cents (**\$11.70**); **2” – Ninety three** dollars and sixty-six cents (**\$93.66**); **3” - One hundred seventy five** dollars and sixty-three cents (**\$175.63**). (Actual meter size will be determined by availability in warehouse). If meter usage is for potable irrigation or reclaim water irrigation, consumption charges could be billed at a different rate.
3. Applicant may have Hydrant Meter assembly relocated to another location at a cost of fifty dollars (**\$50.00**) per relocation.
4. Hydrant Meter shall be provided and installed by the City of Oviedo’s Utility Division. Hydrant Meter shall **ONLY BE RELOCATED, MAINTAINED AND/OR REPAIRED BY THE CITY OF OVIEDO UTILITY PERSONNEL**. Contact the Cross Connection Control Division (407) 971- 5693 for meter relocation.
5. **Deposits will be forfeited if a Hydrant Meter Assembly is tampered with, modified and/or moved by someone other than City of Oviedo Authorized Personnel.**
6. The Hydrant Meter Assembly must be available and accessible for inspection at all times.
7. The meter shall be read and billed monthly or as directed by the Finance Department. Payment shall be made within 30 days of billing to avoid Hydrant Meter pickup. The Hydrant Meter will only be reinstalled after payment of all outstanding fees are paid. A 10% late fee shall be assed on any payment received after 30 days.
8. It is the applicant’s responsibility to notify the City of Oviedo when the applicant is done with the Hydrant Meter so that a final reading can be taken, and, the City can retrieve the meter.
