SUBJECT:	Resolution No. 2760-13 Carry Forward Budget Amendment

Introduction: This is a request for City Council to approve the carry forward budget amendments that involve adjustments to the revenues and expenditures of each fund. City financial policies require Council approval of budget amendments for all inter-fund transfers regardless of the amount, increases or decreases in appropriated fund balance, and for any increase in the total approved appropriation level of a fund. To the extent that actual expenses exceed the approved appropriation level, the City Council must provide formal budget authority that recognizes the unanticipated revenues and expenses.

Discussion: The budget amendment provided in Exhibit 1 of Resolution 2760-13 will affect the fund totals of the affected funds. The changes within each of the affected funds reflect the total increase or decrease to the fund and the amendment or change to the revenues, expenses, inter-fund transfers, and reserves and appropriated fund balance.

Budget Impact: The Carry Forward Budget Amendment is detailed in Exhibit 1 and includes the selected funds indicated in this memorandum. The amendment totals \$9,589,432. The source of funds will be fund balance. The original FY 13-14 budget is indicated where an adjustment to the fund is expected. The amended budget for FY 13-14 reflects the carry forward amount indicated in Exhibit 1.

Carry forward of the funds within the General Fund include:

- Software Upgrade & Training with KRONOS
- Training and Succession Planning
- Cell phones for the Police Department
- Planning Review and Surveying Agreements
- Resurfacing the basketball and tennis courts
- Storage Shed at the Gym awaiting Inspection

The total General Fund impact of the carry forwards is \$92,408 and for FY 13-14, the effect on the budget is indicated as:

RESOLUTION NO. 2760-13

A RESOLUTION OF THE CITY OF OVIEDO, FLORIDA, AMENDING THE 2012-2013 FISCAL YEAR ANNUAL BUDGET; APPROVING A BUDGET AMENDMENT; PROVIDING FOR CONFLICTS; SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, City financial policies require Council approval of budget amendments for all interfund transfers regardless of the amount; increases or decreases in appropriated fund balance; and for any increase in the total approved appropriation level of a fund; and,

WHEREAS, to the extent that proposed expenditures exceed the approved appropriation level, the City Council must provide formal budget authority that recognizes the unanticipated revenues of the FY 2013-2014 budget will increase the expenditure for proposed adjustments; and

WHEREAS, The City Manager requests the City Council to amend the annual budget for FY 13-14 relative to unanticipated revenues and expenses received or incurred during FY 12-13; to approve certain interfund transfers not included in or changed from the adopted FY 13-14 budget; and to establish formal budget authority for items approved by the City Council during FY 13-14; and;

WHEREAS, Florida Statutes allow for budget amendments to be posted on city web sites within 5 days following the approval of the budget amendment.

WHEREAS, the use of fund balance of each fund listed in Budget Amendment - Exhibit 1 is required in order to fund the carry forwards presented.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OVIEDO, FLORIDA, THAT:

SECTION 1: The City Council hereby amends the 2013-2014 Fiscal Year Annual Budget as provided in the Budget Amendment - Exhibit 1; as set forth in this resolution.

SECTION 2. Conflicts. All Resolutions or parts of Resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

SECTION 3. Severability. If any Section or portion of a Section of this Resolution proves to be invalid, unlawful, or unconstitutional, it shall not be held to invalidate or impair the validity, force, or effect of any other Section or part of this Resolution.

SECTION 4: This Resolution shall take effect immediately upon its adoption.
