Capital Recovery Charges

Capital recovery charges are to be assessed against new applicants or existing water/sewer customers as a way to recover all or part of the cost associated with the need of additional system capacity which is constructed for their use. Capital recovery charges shall be based upon the estimated daily flows calculated by the Project Engineer/Applicant and approved by the Public Works Department and assessed at the rate set from time to time by Resolution of the City Council.

Except as otherwise provided herein, each applicant of new water/sewer service, or a significant change to an existing water/sewer service, shall apply to the City of Oviedo Public Works Department to purchase water/sewer capacity. Based upon the amount of water/sewer service demand estimated by the applicant and concurred with the Public Works Department, the Public Works Department will allocate water/sewer service capacity and reserve said capacity at the time the Florida Department of Environmental Protection (FDEP) permit applications are received by the City, or at the time the City is required to make payment for applicant's capacity request from wholesaler supplier of capacity, or at the time of building permit issuance, whichever come first. No building permit shall be issued until all applicable capital recovery charges, meter installation charges, and security deposits have been paid to the City. For both residential and commercial developments, each building shall be required to be metered separately.

The capital recovery charge rate, the minimum meter installation charge, including boxes or vaults, and security deposits shall be established by Resolution of the City Council. The amount to be paid by the applicant shall be calculated as follows:

A. Capital Recovery Charges:

1. Commercial, the greater of:

- a. $\text{RATE} \times \text{GALLONS PER DAY (GPD)} = \text{CAPITAL RECOVERY CHARGE}$
- b. $\text{RATE} \times \text{MINIMUM GPD} = \text{CAPITAL RECOVERY CHARGE}$
(Water minimum = 350 GPD / Sewer minimum = 300 GPD)

2. Residential:

- a. $\text{RATE} \times \text{Equivalent Residential Unit (ERU)} = \text{CAPITAL RECOVER FEE}$
(1 ERU per residential dwelling)

Re: Seminole County Capacity Calculation Change

Dear Customer:

On June 22, 2021 the Seminole County Board of County Commissioners approved an increase in Water and Sewer capacity fees and in the way they are calculated. Effective June 29, 2021, the following will be the method for calculating capacity reservation:

- Single Family Residential, per dwelling unit will be \$3,175 for wastewater
- Multi-Family Residential, will be calculated by square footage. (\$1.50 per sqft wastewater)
Min per dwelling unit \$2,223.00 and Max \$3,175.00
- Non Residential (Business/Retail), is calculated by ERC factors based on the size of the meter providing service x \$3,175.00. See below

EXAMPLE: Business will be served by a 2" meter. 5.33 erc x \$3,175.00 = \$16,922.75 wastewater capacity.

For further explanation or details please see the Seminole County Administrative Code 20.45 Water & Wastewater Capacity Fees and User Charges.

This letter also serves as notification of proposed rate changes to potable water, sanitary sewer and reclaimed water for the customers of Seminole County. The proposed rate change includes a 4.6% increase in water, sewer and reclaimed water. The changes will be considered by the Board of County Commissioners on Tuesday July 27, 2021 during the regularly scheduled meeting. The changes, if approved would be effective on bills rendered October 1, 2021. An additional letter will be sent out once the BCC approves the recommended changes.
